## 第一章 总则

**Chapter 1 General Provisions** 

## 6

7 第一条 为做好国际学生学籍管理工作,依据《高等学校接受外国留学生管理规定》(教育部、外交

- 8 部、公安部令第9号)等中国相关法律、法规和《中国科学院大学招收与培养国际学生管理规定》等学校 9 相关规章制度,结合实际情况,制定本细则。
- Article 1 These implementation rules are set on-demand and in accordance with Administrative Rules on the
  Acceptance of Foreign Students by Colleges and Universities (NO.9 Decree of the Ministry of Education,
  Ministry of Foreign Affairs and Ministry of Public Security) and Administrative Rules on the Enrollment and
  Education of International Students of University of Chinese Academy of Sciences and other related Chinese laws
  and regulations and university rules.
- 15 **第二条** 本细则所称国际学生是指中国科学院大学(简称"国科大")招收录取,在中国科学院所属研 16 究院、所、台、站、中心等单位及国科大校部各院系(以下简称"培养单位")接受研究生教育的非中国籍 17 学生。
  - **Article 2** 'International Students' mentioned in these rules refer to non-Chinese students enrolled at UCAS to receive graduate education at academies, institutes, observatories, stations and centers affiliated with the Chinese Academy of Sciences and all schools and departments of UCAS (hereinafter referred to as *host institutes*).

#### **Chapter 2 Admission of New Students**

- 第三条 新生应当在录取通知书规定的日期,由本人携带有效普通护照(原件)、中国科学院大学录
   取通知书(原件)和来华留学签证申请表(原件)以及新生入学须知中规定应提交的有关材料,到录取通
   知书指定的地点报到入学,办妥各项入学手续。
- Article 3 Students should bring valid passport (original copy), letter of admission (original copy) and *Visa*Application for Study in China (original copy) and other materials listed in the admission notice, within the period stated in the letter of admission to register in designated places and go through all other entrance procedures.
- 29 **第四条** 新生遇有特殊情况不能按时报到入学的,须凭相关证明在录取通知书规定的报到日期之前请 30 假,申请延期入学并获得批准。请假期限不得超过 14 天。
- Article 4 For those who cannot register on time, please ask for a leave with related proof before the registration deadline as stipulated in the admission notice and apply for permission for delayed registration. The

- delay should not exceed 14 days.

- 36 Students should fill in the *Leave Request Form For International Students of UCAS* (Appendix 1,

- 44 第五条 新生按录取通知书规定向培养单位报到时,培养单位应认真检查新生报到凭证,核实身份,
- 45 按规定收取相关费用交纳凭证,发放学生证和入学相关材料,填写《中国科学院大学国际学生报到函》(附
- 46 件 2), 报国科大注册学籍, 协助安排新生住宿, 督促其在入住后 24 小时内到当地派出所履行临时住宿登
- 47 记义务。
- 48 **Article5** Host institute should check carefully the registration material students bring with them, check up
- 49 their identities and require related proof for payment of fees, issue student card and other admission materials, and
- 50 fill in the Form for UCAS New International Student to Register at Host institute (Appendix 2), record online
- for registration, help students arrange dormitories and require them to go through temporary residence procedures
- at the local police station 24 hours after checking in the dormitory.
- 53 第六条 新生报到后,培养单位应在30天内,按照相关规定,对新生的身份信息、最后学历学位证

- 55 Article 6 Host institutes should double check students' identities, certificates for the degrees they last
- acquired and health condition 30 days after their registration.

- 58 1) Grant student status to those who pass the check.
- 59 (二)对于经复查不合格的,培养单位应书面提出,报国科大批准,取消入学资格、注销学籍。相关

- 2) Report the situation in paper to UCAS and revoke the students' qualification and cancel their student status
- in the student status for those who fail to pass the check and all expenses incurred should be borne by the students
- 63 themselves.
- 64 (三)对于复查时发现患有不能或不宜在华学习的疾病的,可申请保留入学资格。应回国休养。相关
- 65 费用学生自理。

- 3) Apply for retaining the admission qualification for students who are found with diseases that prevent them from studying in China or are considered unsuitable to study in China, and ask them to go back to their home country for recuperation. All expenses incurred will be borne by the students themselves.
- 69 **第七条** 符合入学条件的国际学生新生,因病或因其他合理事由,超过学校规定的请假期限不能报到 70 入学的,或在新生复查期内发现患病不能坚持学习或不宜在华学习的,可以申请保留入学资格。保留入学 71 资格的期限最长不超过一学年。

- **Article7** Qualified international students who cannot register after the allowed leave period because of physical conditions or other reasonable reasons, or diseases that prevent them from studying in China or are considered unsuitable to study in China during the double check process, can apply for retaining admission qualification. The retaining period should not exceed 1 academic year.

  - Application for retaining admission qualification should be submitted within the valid registration period and the students should fill in the *Application Form for Preserving/Regaining Admission Qualification* (Appendix 3), ask for UCAS' approval after signed by the supervisor and host institute. Those who apply for retaining admission qualification because of diseases should also submit proof from public hospital to show they are unable and unsuitable to study in school.

- Article 8 Students whose admission qualification is retained should apply for admission at least 60 days before registration during the retaining period. Students who fail to apply for admission 60 days before registration or fail to pass the double check of admission will have their admission qualification cancelled after the approval of UCAS.

- diseases should also submit proof for recovery from public hospital.

- Article 9 Master students who are granted the opportunity to transfer to doctoral study but have not officially
- done so and who apply for retaining the qualification for the transfer to doctoral study because of illness can
- 108 continue their doctoral study after they recover or apply for transferring to master degree study.
- 109 第十条 新生无正当事由不按规定交纳相关费用的,经培养单位提出,报国科大批准,取消入学资格。
- 110 Article 10 For students who fail to pay related fees without reasonable reasons, the host institute can report
- to UCAS and cancel their admission qualification.
- 112 第三章 注册、考勤与请假
- 113 Chapter 3 Registration, Attendance and Leave
- 114 第十一条 国际学生应按学校规定,每学期在规定时间内持本人有效普通护照和学生证,到在读单位
- 115 办理注册手续,按规定交纳相关费用。
- 116 Article 11 International students should go through registration and pay related fees bringing valid passport
- and student card every semester within a designated period of time.
- 118 不能按时注册的,应当事先向在读单位请假(由学生本人填写《请假单》,获得批准方为有效),申请
- 119 暂缓注册。
- Those who cannot register on time should ask the host institute in advance for leave (fill in the *Leave Request*
- 121 Form, which is only valid when approved) for a delayed registration.
- 122 第十二条 有下列情形之一的,不予注册,不能享受在校生相关待遇:
- 123 Article 12 Students cannot be registered nor enjoy related student treatments if they:
- 124 (一)不能按时注册却又不履行暂缓注册手续的;
- 1) cannot register on time and fail to apply for delayed registration;

- 2) fail to pay related fees without reasonable reasons;

- 4) fail to finish their study after the maximum term of study (suspension period included).

135	Article13 After the registration deadline in each semester, all host institutes should timely check the situation
136	of those who fail to register on time and submit the name list of students who are considered dropping out and the
137	name list of students who are denied registration and student treatment within one month after the registration
138	deadline.
139	第十四条 国际学生应当按时参加培养计划规定的课程及相应的活动,接受各种教育必修环节的考
140	核。不能按时参加的,应事先向在读单位请假(由学生本人填写《请假单》),获得批准方为有效。未经批
141	准而缺席者,导师及管理人员应对其批评教育,情节严重的给予纪律处分,直至退学处理。
142	Article14 International students should attend the courses and take part in activities under the education
143	program and take all compulsory education tests. Students who cannot do so should ask approval for a leave (fill
144	in the Leave Request Form). Those who are absent without approval will be criticized by the supervisor and
145	management staff, or be punished or even expelled in the event of a serious breach of rules.
146	第十五条 国际学生因私请假应当填写《请假单》,随附相关材料,经批准方有效。《请假单》留存在
147	读单位主管部门。请假期满应办理销假手续。未办理销假者,超假时间视作未请假处理。
148	Article15 International students who want to ask for a leave should fill in the Leave Request Form and
149	submit related materials, which are considered effective when approved. The Leave Request Form will be saved
150	on file. When the leave expires, students should go through procedures to terminate the leave. If students fail to go
151	through the termination procedures, the period after the expiration will be considered as leave without approval.
152	国际学生因公出差或假期在外遇有特殊情况要延期返回培养单位的,可以用传真、电子邮件等书面方
153	式请假,返回后应当补办手续。
154	Those who have to delay their return to the host institute later because of business trip or special situation on
155	a holiday can ask for a leave via fax, email or in other written documents and make up for the procedures upon
156	their return to school.
157	第十六条 国际学生自行安排的实习、会议、培训等学术和非学术活动视为因私行为,一般应在假期
158	进行。
159	Article16 Academic and non-academic activities including internships, conferences, training sessions
160	arranged by students themselves are considered personal behaviors and should be conducted during holidays.
161	第四章 变更专业、导师、培养单位和转学
162	Chapter 4 Change of Major, Supervisor, Host institute and Transfer to another School
163	第十七条 国际学生无特殊理由,一般应当按原申请攻读的专业完成学业。遇有特殊情况确需变更专

业的,经培养单位确认理由充分、正当,在征得导师同意后,可在本单位内调整专业。培养单位根据发展

- 需要,或遇有导师调动等特殊情况,经学生本人同意,可在本单位内调整其专业。
- Article 17 International students are supposed to finish schooling with their original major without special
- reasons. If there is a need to change major, they can change to a major within the same host institute when deemed
- as reasonable and justifiable by the host institute and approved by the supervisor. The host institute can change
- major for students within the institution after the students' permission in the event of a transfer of supervisor out
- of development need.
- 171 申请变更专业,由变更需求提出方填写《中国科学院大学国际学生学籍变动审批表》(附件 4,以下简
- 172 称《学籍变动审批表》),随附相关材料,经学生本人、转出专业导师、转入专业导师意见后,分下列情形
- 173 进行审批:

- 174 Students who want to change their major should fill in the Status Change Application Form for
- 175 International Students of UCAS (Appendix 4, Status Change Application Form), submit related materials and
- go through the following processes after signed by the students themselves, original supervisors and target
- 177 supervisors.

- 186 (三) 跨学科门类调整攻读专业的,在申请调整攻读专业前应按照拟调整学科培养方案和导师要求修
- 187 订国际学生培养计划,在培养单位初审后,经拟转入专业所在学科群学位评定委员会会议审核,报国科大
- 188 审批。
- 189 3) Students who want to change major to a different category of disciplines shall revise the international
- student education plan according to the target major education plan and the supervisor's requirements before
- applying for a change of major, which should be pre-reviewed by the original host institute, approved by
- Academic Degree Evaluation Committee of the target major, and finally approved by UCAS.
- 193 第十八条 毕业注册前六个月内不得申请调整专业。
- 194 Article 18 International students cannot apply for a change of major within 6 months before graduation
- 195 registration.
- 196 第十九条 国际学生无特殊理由,一般应当在原报考导师的指导下完成学业。遇有特殊情况确需变更
- 197 导师的,经培养单位确认理由充分、正当,在征得原导师同意后,可允许学生在本单位内重新选择导师。

- 198 培养单位遇有特殊情况,在征得学生本人和原导师同意后,可允许学生在本单位内重新选择导师。
- 199 Article 19 International students are supposed to finish schooling under the guidance of their original
- supervisors without special reasons. They can change the supervisor, if there is such a need, within the same host
- 201 institute if deemed as reasonable and justifiable by the host institute and approved by the supervisor. Host
- institutes can change supervisors for students after the student's and the supervisor's permission special cases.
- 203 申请变更导师,由变更需求提出方填写《学籍变动审批表》),随附相关材料,经学生本人、原导师、
- 204 新导师及培养单位签署意见后,报国科大审批。
- Students who want to change their supervisors should fill in the Status Change Application Form, submit
- related materials and ask for UCAS' approval after signed by the students themselves, original supervisors, target
- supervisors and host institutes.
- 208 第二十条 国际学生无特殊理由,一般应在原报考的培养单位完成学业。遇有特殊情况确需变更培养
- 209 单位的,在征得原导师、原培养单位同意,并经国科大确认理由充分、正当后,可允许学生重新选择导师
- 210 及培养单位。培养单位遇有特殊情况,在征得学生本人和原导师同意后,可允许学生重新选择导师及培养
- 211 单位。新导师、新培养单位应按国科大有关规定对申请者进行入学考核。
- 212 Article20 International students are supposed to finish schooling in their original host institute without
- special reasons. They can change to a new supervisor and the host institute, if there is such a need, when approved
- by the original supervisor, host institute and deemed as reasonable and justifiable by UCAS. In special cases, host
- 215 institutes can allow students to change supervisor and host institute after the permission of the students themselves
- and their original supervisors. The new supervisor and host institute should test students according to related rules
- 217 of UCAS.
- 218 申请变更培养单位,由变更需求提出方填写《学籍变动审批表》)(由原培养单位提供),随附相关材
- 219 料,经学生本人及原导师、原培养单位签署意见后,寄给新导师、新培养单位签署意见。由新培养单位寄

- 221 Students who want to change their host institute should fill in the Status Change Application Form (provided
- by the original host institute), submit related materials, which will be signed by the students themselves, original
- 223 supervisors and original host institutes and mailed to the new supervisor and host institute for signature, which
- will then be mailed to UCAS for approval by the new host institute.
- 225 第二十一条 有下列情形之一的,不得变更培养单位:
- Article 21 Students of the following cases cannot change the host institute:
- 227 (一)入学未满一学期的;
- 1) having received education for less than one semester after enrollment;
- 229 (二)由低学历层次转为高学历层次的;
- 230 2) changing from a lower degree to a higher degree;

- 231 (三)应予退学的;
- 232 3) required to drop out;
- 233 (四)无正当理由的。
- 4) without justifiable reasons.
- 235 第二十二条 中国境内其他学校在读国际学生申请转入国科大学习的,应先出具转学申请书及原学校
- 236 同意转学函件,按国科大招收国际学生的相关规定提交入学申请材料,经导师及培养单位签署意见后,办
- 237 理录取及入学相关手续。若申请者为中国政府奖学金生,还应出具所属国驻华使馆同意函,并征得国家留
- 238 学基金管理委员会同意。

- Article 22 International students of other Chinese universities who want to transfer to UCAS should submit
- transfer application and approval letter of the original university, admission application materials of UCAS and go
- 241 through registration procedures after signed by supervisor and host institute. If the applicant is the Chinese
- Government Scholarship winner, he/she should submit the approval letter of the Embassy of its home country in
- 243 China and ask for approval from the China Scholarship Council.
- 244 第二十三条 国际学生无特殊理由的,应按原计划在国科大完成学业。遇有特殊情况确需转学到中国
- 245 境内其他学校的,应事先征得导师、培养单位的同意。国科大确认理由充分、正当的,给予开具同意转学
- 246 函。获准转学的学生应在批准后 14 天内办理离校手续。
- Article 23 International students should finish schooling at UCAS without special reasons. Those who need
- 248 to transfer to other Chinese universities should ask for approval from the supervisor and host institute. UCAS will
- 249 grant approval letter if it deems the reasons to be convincing and justifiable. Students should go through
- transferring procedures 14 days after getting the approval for school transfer.

#### 第五章 变更培养层次

#### 252 Chapter 5 Change of Student Category

- 253 第二十四条 非应届在读硕士生申请攻读博士学位,可在第3学期及以后,申请参加国际学院博士候
- 254 选人资格考试。资格考试通过的,填写《中国科学院大学国际学生培养层次变更申请表》(附件 5,以下简
- 255 称《培养层次变更申请表》),并提交相关材料,经导师、培养单位签署意见后,报国科大批准。对于获准
- 256 硕转博的学生,自下一学期起正式转入博士阶段的学习,享受博士生相关待遇。
- Article24 Non-fresh graduate students in school who want to apply for doctoral degree can sit for the PhD
- 258 candidate qualification test of the International School in or after the 3<sup>rd</sup> semester. Those who pass the test should
- 259 fill in the Application Form for Changing Student Category of UCAS (Appendix 5, hereinafter referred to as
- 260 Application Form for Changing Student Category), submit related materials and ask for UCAS' approval after
- signed by the supervisor and the host institute. Those who are approved can officially begin their doctoral study
- since the next semester and enjoy doctoral treatments.
- 263 第二十五条 获准硕转博的国际学生,经培养单位认定不再适合攻读博士学位的,可填写《培养层次

- 264 变更申请表》,随附相关材料,报国科大批准,将博士学籍转成硕士学籍。获准博转硕的国际学生应在自
- 265 批准后下一学期起1年内按硕士生培养规定完成学业。
- Article 25 International Students who are allowed to change from master to doctoral degree, if deemed by
- the host institute as not suitable for doctoral study, should fill in the Application Form for Changing Student
- 268 Category and submit related materials to ask for UCAS' approval to change the doctoral degree to master degree.
- When approved by UCAS, the students should begin their master degree study from the next semester and finish
- the schooling within one year.
- 271 第二十六条 博士生入学未满 1 年,经培养单位认定不再适合攻读博士学位的,可填写《培养层次变
- 272 更申请表》,随附相关材料,报国科大批准,将博士学籍转成硕士学籍。获准博转硕的国际学生应在自批
- 273 准后下一学期起2年内按硕士生培养规定完成学业。
- Article26 PhD candidates in school for less than 1 year. if deemed by host institute as not suitable for
- 275 continuing the study, can fill in Application Form for Changing Student Category, submit related materials and
- ask for approval of UCAS to change the education level to Master's degree. Those who are permitted should begin
- their master degree study from the next semester and finish the schooling within two years.

#### 278 第六章 休学与复学

### Chapter 6 Suspension and Resumption of Schooling

- 280 第二十七条 国际学生因病或其他情况需中止学习一段时间的,可以申请休学。有以下情形之一的,
- 281 应当办理休学:

- Article 27 Those who need to suspend schooling because of diseases or other special situation can apply for
- suspending schooling, which is required if the students:
- 284 (一)因病或其他原因,不能参加正常培养计划规定的活动,需请假超过1个月的;
- 285 1) cannot take part in planned activities of the education program because of diseases or other reasons, and
- need to take a leave for more than one month;
- 287 (二) 怀孕超过 6 个月的;
- 288 2) are pregnant for more than 6 months;
- 289 (三)未能按学校规定注册在读的。
- 3) were not registered for schooling according to requirements.
- 291 第二十八条 休学申请由本人提出,填写《学籍变动申请表》,随附相关材料,经导师、培养单位签
- 292 署意见,报国科大批准。因重病和传染病休学的,可以由他人代办休学手续。
- 293 Article 28 Students should apply for suspension of schooling by themselves, and fill in Status Change
- 294 Application Form, submit related materials, ask for approval from UCAS after signed by the supervisor and host
- 295 institute. Those who need to suspend schooling because of severe diseases or infectious diseases can entrust others
- to go through suspension procedures.

- 297 因特殊原因,培养单位认为应当休学的,由培养单位提出,经学生本人同意,填写《学籍变动申请表》, 298 随附相关材料,报国科大批准,可以休学。 299 If the host institute deems that the student should suspend schooling because of special reasons, the host 300 institute should propose after approval by the student and fill in Status Change Application Form, submit related materials, file for approval from UCAS and go through suspension procedures. 301 **第二十九条** 休学一般以半年为限, 在校期间累计最长不得超过1年。休学时间从实际停学时间算起。 302 303 因病住院治疗的,休学时间应从住院之日算起。 304 Article 29 Each suspension should not exceed the limit of 6 months, and the total suspension period should 305 not exceed 1 year during school years. The time of suspension starts from the very first day of suspension. 306 Suspension due to hospitalization should begin from the very first day of hospitalization. **第三十条** 获批休学的国际学生,应当自批准之日起7天内,按相关规定完成离开培养单位的手续。 307 休学期间不享受在校生待遇,且应当离境。所有相关费用由学生本人自理。 308 309 Article 30 Those who are allowed to suspend schooling should finish all related procedures within seven 310 days after the date of approval and during their suspension, they will not enjoy treatment of students in school, and 311 should leave China.
